

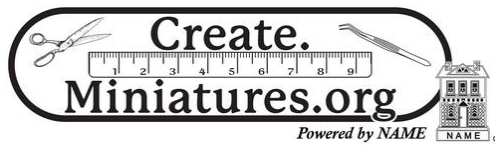
## NAME CREATE GIFT & GAB AGREEMENT

Create Gift & Gab Agreement for <<Presenter Name>>

By agreeing to provide a Gift & Gab for the NAME CREATE platform, I acknowledge I will abide by the following terms:

1. My maximum number of guests is \_\_\_\_\_. I commit that I will provide prepared gifts for the actual number of guests up to my maximum number. I understand that I am responsible for shipping my Gift & Gab gifts to the registered guests a minimum of **15 days** prior to the Gift & Gab presentation date. I will provide proof of shipment and tracking numbers for all packages to the NAME office for reimbursement after the Gift & Gab has been held.
2. My Price to NAME for the Gift & Gab is \$\_\_\_\_\_
3. NAME will assess a per capita fee for every person that registers for the Gift & Gab. The per capita assessed is as follows: \$28 for Gift & Gabs if the gift is priced at \$50 or more or \$23 if the Gift is priced at less than \$50. Therefore, the published cost per person will be your gift with the per capita added to that cost. An \$11.00 discount will be given to NAME members upon checkout. If I cancel the Gift & Gab, I agree to pay the per capita per guest registered at time of cancellation.
4. I understand that the payment I receive will be the cost of the gift plus shipping costs charged to the guest. All payment to presenters will occur no later than six (6) business days after the Gift & Gab presentation provided NAME has received proof of shipment and link to the video has been provided to guests. My shipping fees are as follows:

I will not ship to the following countries (e.g., you may choose not to ship to the UK due to the UK Vat regulations) \_\_\_\_\_
5. My deadline for acceptance of participants in order to assure shipping in time for arrival prior to my ZOOM session is \_\_\_\_\_ (date must be a minimum of 15 days prior to the Gift and Gab presentation date). My deadline for acceptance of participants for other countries is \_\_\_\_\_. I understand that my gift will remain available for sale until I sell out or until the day of the Gift & Gab, whichever comes first. However, I am not obligated to ship gifts for orders that come in after the shipping deadline until after the ZOOM session. Those signing up late for the Gift & Gab will receive the link to the class recording when it is available.
6. NAME will contact you right away if a guest signing up is outside the USA so you can ship the gift as quickly as possible. As orders are received, you will be sent copies of the orders. These orders include the student names, shipping addresses and email addresses. You are responsible for keeping your own records of your class participants. Periodically a list of student names will be sent for comparison to make sure that all orders were received.
7. NAME will keep track of a waiting list, in the event that my Gift & Gab sells out, and if additional gifts can be prepared people on the wait list will receive priority to sign up for the Gift & Gab

through the CREATE site.

8. Presenting a Gift & Gab through the Create platform requires that it be recorded. The NAME **ZOOM** platform can do this for you. Gift & Gabs on the NAME **ZOOM** platform will include a moderator to start the recording of the Gift & Gab session and to help people log on if needed. They may then leave the Gift & Gab and turn the hosting over to you.

Although we prefer that you use the NAME Zoom, you may choose to use your own Zoom account. However, your Gift & Gab shall still be recorded and a link to your video shall be provided to guests within 5 days of Gift & Gab.

9. By signing this Agreement, you agree to permit NAME to store the video on the NAME Vimeo site for a **minimum of six (6) months** after the date of the end of the Gift & Gab for use by you and your guests whether using the NAME ZOOM account or your own Zoom account to record. NAME will not use the video for any reason other than distribution to the guests unless noted below. If the NAME Zoom account is used NAME will send you a video link within 5 days of Gift & Gab for you to email to your guests. If your Zoom account is used you agree to provide the link to your video to your guests within 5 days of receiving access to upload the video from your Zoom account.

10. **OPTION**--- I grant permission to NAME to use my video as an educational tool on the Create platform after my initial presentation. Instructors have no obligation to provide gifts or address questions from any potential viewer accessing these free videos.

11. NAME will work with you to schedule the date and time for your Gift & Gab. **The date, time, and Zoom Gift & Gab link will be sent with the presentation information to each guest by you.** This link is not to be shared to anyone that is not a paid registrant of the Gift & Gab offered.

12. **A \$25 non-refundable CREATE fee must be included with this Agreement.**

13. Should I be unable to present my Gift & Gab due to a last-minute hospitalization or death of an immediate family member, I shall notify the NAME Office and CREATE Gift & Gab Chair. (Immediate family is defined as parent, spouse, partner, son, daughter or family member residing within the home.) I understand that the Create Gift & Gab Chair will work with me to re-schedule the Gift & Gab date if at all possible to avoid cancellation. Total cancellation will result in the full CREATE Fee charges. Should a guest cancel the order for the Gift & Gab prior to shipping due to the presenter not being available to teach at the intended time, a full refund shall be granted to the guest. No refunds will be given for already shipped gifts. No substitute presenter shall be designated to present the Gift & Gab.

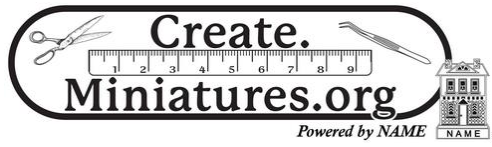

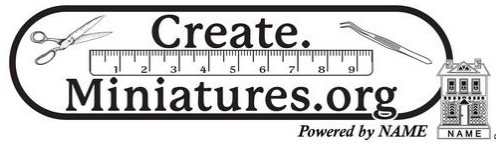
These Gift & Gab Gifts will be available on Create for 30 days after your live Gift & Gab session, or until they are sold out, whichever comes first.
